- Leads secondary school principals in fostering a culture of academic and social excellence through School Improvement Plan implementation.
- Supervises, evaluates and recommends improvements to school principals regarding program operation, discipline, staffing, budget, and facility maintenance/operation.
- Models effective instructional and operational leadership practices for secondary school principals.
- Coaches and supports secondary school administrators (principals and assistant principals) in instructional and operational leadership.
- Collaborates with the Executive Director of Secondary Schools to oversee the Middle and High School Curriculum departments and manages the implementation of resources and tools for all middle and high school teachers and leaders.
- Leads the Chief of Secondary Schools with program development, curriculum oversight, and project management.
- Leads the planning, implementation, articulation and evaluation of the curriculum and instructional program.
- Direct and coordinate program planning to involve District and school personnel, community representatives and students when appropriate.
- Assist school personnel in initiating and implementing new programs.
- Assist schools in keeping abreast of state mandates, District initiatives and opportunities for participation in grants or special programs.
- Provide assistance for the development and implementation of performance standards.
- Supervise the implementation of the District's Pupil Progression Plan.
- Serve as the District contact for the Southern Association of Colleges and Schools accreditation.
- Assist school principals, as needed, in the recruitment, selection, placement and appraisal of school-based personnel.
- Assist in the development of administrative guidelines for secondary school education programs.
- Assist in the development of policies for secondary school education programs.
- Maintain a close working relationship with school administrators to ensure information exchange, coordination of efforts and general support for the decision-making process.
- Work with schools and District personnel in obtaining information regarding the effectiveness of program implementation.
- Work with appropriate personnel in the planning, modification and construction of school facilities.
- Maintain a close working relationship with school personnel to ensure articulation of programs and services.
- Oversee and assist with categorical and special programs and grants for ~~middle~~ secondary school programs.
- Work with athletic directors to develop District procedures and to promote equity in programming for secondary school students.
- Direct the Summer School Program for secondary school students.
- Assist in the interpretation of programs, philosophy and policies of the District to staff, students and the community.
- Interact with parents, outside agencies, business and community to enhance understanding of District initiatives and priorities and to elicit support and assistance.
- Maintain expertise in assigned areas to fulfill project goals and objectives.
- Facilitate the development, implementation and evaluation of staff development activities in assigned areas.
- Develop annual goals and objectives consistent with and in support of district goals and priorities.
- Attend training sessions, conferences and workshops to keep abreast of current practices, programs and legal issues.
- Direct the development of the secondary school budgets and ensure that expenditures are in accordance with budget allocations and the District's strategic plan.
- Supervise assigned personnel, conduct annual performance appraisals and make recommendations for appropriate employment action.
- Prepare or oversee the preparation of all required reports and maintain appropriate records.

- Serve on District, state or community councils or committees as assigned or appropriate.
- Represent, consistently, the District in a positive and professional manner.
- Utilize appropriate strategies and problem-solving tools to make decisions concerning planning, utilization of funds, delivering services and evaluation of services provided.
- Assist in implementing the District's goals and strategic commitments.
- Exercise proactive leadership in promoting the vision and mission of the District.
- Provide oversight and direction for cooperative planning with other agencies.
- Use appropriate styles and methods to motivate, gain commitment and facilitate task accomplishment.
- Perform other incidental tasks consistent with the goals and objectives of this position
- Every Sarasota County Schools employee has emergency response responsibilities, though not every position will require routine assignments during an emergency event. All employees are subject to recall around the clock for emergency response operations, which may require irregular work hours, work at locations other than the normal work location, and may include duties other than those specified in the employee's official job description. Assignments in support of emergency operations may be extensive in nature, with little advance notice, and may require employees to relocate to emergency sites with physically and operationally challenging conditions.

### **PHYSICAL REQUIREMENTS:**

Light Work: Exerting up to 20 pounds of force occasionally and/or up to 10 pounds of force as frequently as needed to move objects.

### **TERMS OF EMPLOYMENT:**

Salary and benefits shall be paid consistent with the District's approved compensation plan. Length of the work year and hours of employment shall be those established by the District.
