JOB OBJECTIVE:

To analyze, develop, implement and monitor District benefit and risk management programs for compliance with all relevant federal and state regulations, school board policies and collective bargaining agreements.

SUPERVISES:

PERFORMANCE RESPONSIBILITIES:

- Responsible for compliance with federal and state regulations such as PPACA, Section 125, COBRA, HIPAA, GINA, FRS, OSHA, FDOT etc. that govern employee group benefit and risk management programs.
- Work with appropriate departments, consultant/broker and Third Party Administrators (TPA) to ensure timely and accurate compliance reporting to appropriate federal and state agencies.
- Monitor, track, analyze and report to supervisor, regulations that impact employee benefits and risk management programs.
 - Participate in the development, implementation and maintenance of a comprehensive District-wide occupational safety and loss prevention program.
 - Apply knowledge of standard safety practices and risk management techniques to reduce the frequency and severity of losses to the District's self-insured programs.
 - Make periodic inspections and compliance audits to identify unsafe conditions and verify adherence to District safety programs and governmental regulations.
- Responsible for implementing programs and updating District safety procedures and manuals.
- Analyze and interpret data, identify trends and recommend corrective actions based on information in various accident reports for all self-insured risk management programs.

- Assists supervisor as required to manage day to day business of the department safety and liability programs.
- Coordinate occupational safety and health compliance.
- Prepare all required reports and maintain all appropriate records.
- Exhibit support for the District's vision, mission, goals and priorities.
- Assist in the interpretation of programs, philosophy and policies of the District to staff, students and the community.
- Respond to inquiries or concerns in a timely manner.
- Keep Supervisor informed of potential problems or unusual events.
- Work closely with District and school staff to support school improvement initiatives and processes.
- Disseminate information and current research to appropriate personnel.
- Keep well informed about current trends and best practices in areas of responsibility.
- Maintain expertise in assigned areas to fulfill project goals and objectives.
- Facilitate the development, implementation and evaluation of staff development activities provided in assigned areas.
- Promote and support professional growth for self and others.
- Develop annual goals and objectives consistent with and in support of District goals and priorities.
- Maintain a network of peer contacts through professional organizations.
- Attend training sessions, conferences and workshops to keep abreast of current practices, programs and legal issues.
- Serve on District, state or community councils or committees as assigned or appropriate.
- Represent, consistently, the District in a positive and professional manner. Assist in implementing the District's goals and strategic commitments.
- Exercise proactive leadership in promoting the vision and mission of the District.
- Provide oversight and direction for cooperative planning with other agencies.
- Demonstrate initiative in identifying potential problems or opportunities for improvement and take appropriate action.
- Use appropriate styles and methods to motivate, gain commitment and facilitate task accomplishment.
- Facilitate problem-solving by individuals or groups.
- Perform other incidental tasks consistent with the goals and objectives of this position.
- *Every Sarasota County Schools employee has emergency response responsibilities, though not every position will require routine assignments during an emergency event.
