- Develop and implement curriculum and instructional materials for visual and performing arts disciplines.
- Oversee program budgets and manage resource allocation.

- Identify and secure funding opportunities through grants or sponsorships.
- Plan, organize, and execute visual arts exhibits, performances, and other events.

- Recruit, train, and support visual and performing arts teachers and staff.
- Develop professional development opportunities for VPA staff throughout the school year.
- Manage volunteers to ensure volunteers are effectively utilized.
- Foster relationships with local arts organizations, artists, and performers.
- Plan and coordinate outreach programs to promote the arts program within the community.
- Organize artist-in-residence programs and workshops.
- Oversee fundraising initiatives related to the visual and performing arts program.
- Analyze data and reports to identify areas for improvement and program development.
- Prepare reports and presentations on the status and impact of the visual and performing arts program throughout the year.
- Maintain a safe and inclusive learning environment for all participants in the visual and performing arts program.
- Manage inventory of equipment and resources used in the program.
- Consistently delivers tasks on time and to a high standard.
- Willingly accepts and fulfills additional duties assigned by the Principal.

PHYSICAL REQUIREMENTS:
